MIDWESTERN STATE UNIVERSITY (MSU Texas) Dual Credit Enrollment Memorandum of Understanding

Recognizing that there are outstanding students who accelerate their high school academic programs and lack only a partial course load to complete graduation requirements, **Midwestern State University (MSU Texas)** and **Bellevue ISD**, enter into this high school concurrent enrollment agreement:

I. Academic Eligibility Requirements:

- A. The student must have an unweighted high school GPA of 3.0 or higher on a 4.0 scale or top 25% of their high school graduating class.
- B. The student must meet requirements for the Texas Success Initiative (TSI)
 - demonstrates college readiness by achieving the minimum passing standards under the provisions of the TSI as outlined in the Texas Administrative Code; or
 - demonstrates that he or she is exempt under the provisions of the TSI or
 - English II EOC score of 4000 or higher as an exemption for TSIA ELAR/Essay and a minimum score of 460 on the EBRW for the PSAT for dual credit purposes.

II. Application, Registration, and Change of Schedule Procedures:

- A. The applicant must have the following credentials and documentation on file with Midwestern State University Admissions by August I for the fall semester; by December 1 for the spring semester; and by May I for the 1st summer session, or June I for the 2nd summer session:
 - Application for concurrent admission including the statement of agreement signed by the student, parent/guardian, and counselor/principal.
 - 2. Official high school transcript.
 - 3. Texas Success Initiative (TSI) requirement.
 - 4. Official transcripts from other college(s) attended if applicable.
 - 5. Proof of meningitis immunization.
- B. Registration will be coordinated through Midwestern State University Admissions in conjunction with the high school's counselor.
- C. Students must comply with TSI policies.
- D. The student will register and pay all regular tuition and fees during the regular registration period and as a Midwestern State University student will be responsible for observing all University regulations.
- E. The high school counselor and the Midwestern State University dual credit coordinator must approve changes to student schedules including drops or withdrawals.

III. Midwestern State University Academic Record:

- A. Midwestern State University will provide student grades to the high school counselor upon the completion of each semester. Students can access their end of semester grades online.
- B. An official high school transcript relating the student's continued progress should be provided to Midwestern State University Admissions on an annual basis while the student continues in the high school dual credit program.
- C. Official Midwestern State University transcripts will be available upon completion of the dual credit courses.

IV. Disclaimer:

A. Students are required to follow all established University policies and procedures while in the high school dual credit program and on the Midwestern State University campus.

- B. Students will be in regular attendance at both institutions and will be responsible for following regulations on all campuses.
- C. Midwestern State University does not filter Internet access and sites.
- D. Students in this program are not allowed to join fraternities/sororities until they graduate from high school.
- V. Additional requirements, which the high school may wish to place upon the student prior to approval, are beyond the purview of this document.
